WHEREAS

- A. **SXCM** is an established College with a track record of educational excellence and research and with a dynamic programme of collaborative arrangements with many institutions of Colleges, Schools, Hospitals & Industries. The college is accredited to NAAC with B grade.
- B. St. Aloysius's College (Autonomous), Mangaluru is an Autonomous college of Mangalore University, Mangalore, Karnataka. It is a Jesuit Higher Education Institution offering Undergraduate, Postgraduate and Ph.D. The college is accredited to NAAC with A grade.
- C. The Parties are desirous of entering this MoU to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

NOW THIS MOU WITNESSES AS FOLLOWS:

OBJECTIVE

The Parties, subject to the terms of this MoU from time to time in force in each party's place, shall endeavor to strengthen, promote and develop Faculty Development Programs & Student Development Programs and co-operate between the Parties on the basis of equality and mutual benefit.

AREAS OF COOPERATION


The Parties agree to encourage the following activities, in particular, to promote academic cooperation in the following areas:

- Projects and field works in the area of mutual interest;
- Exchange of academic publications and reports;
- Exchange of visiting staffs and students;
- Other activities as mutually agreed.
- Institutional exchanges between faculty and staff from both the institution for development Programs.
- Exchange of information pertaining to developments.
- Cooperation in any other areas as agreed to by the Parties from time to time; and
- The Parties will mutually promote information and activities of partner institutions within the MoU.

ENTRY INTO EFFECT AND DURATION

- This MoU shall become effective as of the date of signatures of both parties, or if the dates vary, then the date of the later signature.
- This MoU shall remain in effect for a period of five (5) years.
- This MoU may be extended for such further period as may be agreed in writing by both parties.
- If the MoU is not renewed by mutual consent, the MoU shall conclude

REVISION, VARIATION AND AMENDMENT


- Either party may request in writing a revision, variation or amendment of this MoU with an approval of other party.
- Any such revision, variation or amendment agreed to by the Parties shall be in writing and shall form part of this MoU.
- Such revision, variation or amendment shall come into force on such date as may be determined by the Parties.
- Any revision, variation or amendment shall not prejudice the implementation of any project, activity or co-operation arising from or based on this MoU before or up to the date of such revision, variation or amendment.


TERMINATION

This MoU may be terminated by either party with a minimum of ninety (90) days written notice to the other party. Activities in progress at the time of termination of this MoU shall be permitted to conclude as planned unless otherwise agreed.
