



Memorandum of Understanding (MoU)
on Academic Cooperation

And

St. Xavier's College, Mahuadanr

The Parties;

This Memorandum of Understanding (hereinafter referred to as "MOU") is entered on by and between Oriental University, Indore Opp. Rewati Range, Gate No.1 Jakhiya, Sanwer Road (hereinafter referred to as "Oriental University"). Dr. Pradyumna Yadav, Registrar is authorized to execute this MOU as per University norms.

And

St. Xavier's College, Mahuadanr situated in Latehar district of Jharkhand state is a co-educational institution. It was established by Hazaribag Jesuit Education Society (HJES), to impart quality higher education primarily to the most neglected and underprivileged students. However the college follows the principle of inclusiveness and hence admits all types of students irrespective of caste, creed, gender and economic disparities. The college is affiliated to the Nilamber-Pitamber University, Medininagar,(Daltonganj), Palamau. It is the only institution of higher learning in the tribal dominated rural sector of this region. It was established in 2011 amid the nature's exotic scenic beauty. It has 10 acres of land in its name and 14.46 acres of land in the parent body's name; a total 24.46 acres of land under its possession. It has been certified by ISO 9001:2015 and accredited to NAAC at B grade

1. The purpose of this MoU is to develop academic and educational cooperation and to promote mutual understanding between the two Parties.
2. Each Party agrees to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.
 - 2.1) Exchange of academic and administrative staff
 - 2.2) Exchange of students
 - 2.3) Conducting collaborative research projects
 - 2.4) Conducting lectures and organizing symposia
 - 2.5) Exchange of academic information and materials
 - 2.6) Promoting collaboration in fields of mutual interest
 - 2.7) Promoting other academic cooperation as mutually agreed
3. The development and implementation of specific activities based on this MoU will be separately negotiated and agreed between both Parties which carry out the specific projects and will be subject to a separate written agreement. Each Party agrees to carry out these activities in accordance with the laws and regulations of the respective Parties after full consultation and approval.

4. It is understood that the implementation of any of the types of co-operation stated in Clause 2 shall depend upon the availability of resources and financial support of the Parties concerned.
5. Both Parties agree that prior written approval is required before using the other Party's name, logo, or other Intellectual Property rights in any advertising or associated publicity.
6. Should the collaborative research activities under this MoU result in any potential for intellectual property, each Party shall seek an equitable and fair agreement as to ownership and other property interests that may arise.
7. This MoU may only be amended or modified by a written agreement signed by the representatives of each Party.
8. This MoU is valid for a period of five years from the date of signing by the authorized signatories of each Party. Each Party shall review the status of the MoU at least three months before the end of the five-year period to determine whether it wishes the MoU to continue and, if so, any modifications that might be necessary. The period of validity of this MoU may only be extended by the mutual written consent of both Parties.
9. This MoU may, at any time during its period of validity, be terminated by one of the Parties upon prior notice to the other in writing not later than six months before the termination date.
10. Each Party therefore agrees that the contents of this MoU and the negotiations in relation to any future proposal remain strictly confidential and each Party hereby undertakes not to disclose the same to any third Party.
